EMERGENCY OVERVIEW

APPEARANCE – Beige to brown powder

ODOR - Odorless

III – COMPOSITION/INFORMATION ON INGREDIENTS

Beneficial endomycorrhizal and ectomycorrhizal propagules on an expanded clay carrier, organic fertilizer, Humics and beneficial bacteria.

IV – FIRST AID MEASURES

Treat symptomatically. Contact poison treatment specialist immediately if large quantities have been ingested or inhaled. No specific treatment.

EYE CONTACT – Wash thoroughly with water for at least 15 minutes. Remove contact lenses. Hold eyelids apart during flushing.
