# 2019-2020 SBM Life Science Company Retailer Co-op & Advertising Policy Effective 10/1/19 to 9/30/20

#### Program Rules

All ads will be paid **3%** of purchases earned from co-op fund. Co-op funds are accrued at **3%** of net purchases (and shipments) at dealer wholesale cost.

Reimbursements are available solely to retailers selling SBM/BioAdvanced products directly to the consumer.

Ask your SBM Life Science Sales Manager for additional promotional opportunities

All Retailer Ads run between October 1st via September 30th are eligible for reimbursement.

Co-op claims must be submitted within 60 days of the date of the ad. Effective co-op accrual dates are 10/1/19 to 9/30/20.

All participating retailers must provide proof of purchase/qualifying orders prior to submitting a claim for reimbursement. The reimbursement procedure is outlined below. Any accrued funds remaining after September 30, 2020 are forfeited. <u>No claims will be accepted after September 30,</u> 2020. 2020.

To be eligible for co-op *credit* reimbursement, the advertisement must be 100% consumer targeted. Examples of this include:

Newspaper, Radio, Television, Direct Mail and In Store Fliers. <u>Any other method(s) must be pre-approved by your SBM Life Science Sales</u> <u>Manage.</u>

Reimbursement applies only towards the cost of space or time directly devoted toward SBM Life Science products and not towards art/production or any other cost of the advertisement.

#### To be reimbursed, all printed materials must include the following:

- A. Picture of the Bio Advanced/SBM Life Science product
- B. A minimum of 2 feature statements about the Bio Advanced product
- C. Advertising funds can be denied if competitive products appear in the same ad
- D. Product Images are available at: www.extranet.Bioadvanced.com

#### Reimbursement Procedure:

In order to receive credit reimbursement, retailers are to send all claims to their <u>distributor</u>. Distributor will <u>submit all claims directly</u> to your SBM Life Science Sales Manager.

In order to process the claim - all of the below must be submitted:

- 1. Proof of Purchases from Distributor (i.e.: purchase recaps)
  - 2. Copy of the Advertisement
- 3. Tear Sheet/Media invoice detailing the:
  - a. Date of ad
  - b. Ad size
  - c. Total Cost of Ad
  - d. Cost proportioned to SBM Life Science

4. Once claim has been submitted and approved for payment - distributor will issue a credit directly to the retailer.

- Use of Co-op for employee apparel is not acceptable.
- All radio, television, email messages and Internet marketing/advertising require prior approval for reimbursement.
